Notice is hereby given that 36th Annual General Meeting of the Members of the Company will be held on Friday, September 30, 2016 at 11.00 A.M. at the registered office of the company i.e. SP-825, Road No.14, Vishwakarma Industrial Area, Jaipur-302013 to transact the business as set out in the Notice of AGM which along with the Annual Report for the financial year 2015-16 have been sent to the members (i) through e-mail at their registered e-mail id and (ii) through physical copy to the members who have not registered their e-mail ids, in the prescribed mode.

Notice of the 36th Annual General Meeting and the Annual Report 2015-16 are also available on the website of the Company i.e. www.bajoriagroup.in.

Notice is further given that pursuant to Section 91 of the Companies Act, 2013 read with Rule 10 of the Companies (Management and Administration) Rules 2014 and Regulation 42 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015, Register of Members and Share Transfer Books of the company shall remain closed from September 24, 2016 to September 30, 2016 (both days inclusive) for the purpose of 36th Annual General Meeting of the Company.

Notice is further given that pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 as amended from time to time and Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company is pleased to provide remote e-voting facility to all the eligible members of the company to cast their vote by electronic means on all the resolutions set out in the said notice. The Company has engaged the services of CDSL as the agency to provide e-voting facility and the business may be transacted through voting by electronic means.

The detailed procedure/instructions for remote e-voting are contained in the Notice of AGM. In this regard, the Members are hereby further notified that :

- a. The Notice of 36th AGM can be seen at company's website www.bajoriagroup.in and at the e-voting website of CDSL i.e. www.evotingindia.com.
- b. The Notice of 36th Annual General Meeting along with the Annual Report for the financial year 2015-16 was sent to the Members of the company at their addresses/registered e-mail Ids on September 1, 2016.
- c. The remote e-voting shall commence from Tuesday, September 27, 2016 at 9.00 A.M. and ends on Thursday, September 29, 2016 at 5.00 P.M. The remote e-voting shall not be allowed beyond the prescribed date and time mentioned above.
- d. A person whose name is recorded in the register of Members/ Beneficial Owners maintained by the depositories as on the cut-off date i.e. September 23, 2016 shall be entitled to avail the facility of remote e-voting as well as voting at the meeting.
- e. Any person who becomes member of the Company after dispatch of the Notice of the Meeting and holding shares as on cut-off date i.e. September 23, 2016 may obtain the User ID and password by sending request at helpdesk.evoting@cdslindia.com . However, if the member is already registered with CDSL for remote e-voting, he/she can use his existing User ID and password for casting the vote through remote e-voting.
- f. The Company shall provide facility for voting by means of Polling Paper at the meeting. The members who are entitled to vote but have not exercised their right to vote through remote e-voting may vote at the AGM through Polling Paper for all business specified in the Notice.
- g. The members who have cast their vote by remote e-voting may attend the meeting but shall not be entitled to cast their vote again.
