सजा के समान है बिना मुकदमे के जेल : सुप्रीम कोर्ट

सुप्रीम कोर्ट ने बिना मुकदमे के जेल को सजा के समान बताते हुए हत्या के प्रयास के मामले में पंजाब के एक व्यक्ति को जमानत दे दी।

अदालत ने यह भी कहा कि व्यक्ति दो साल से जेल में है, जबकि मुकदमे की सुनवाई तक शुरू नहीं हुई है।

न्यायमूर्ति दीपांकर दत्ता और न्यायमूर्ति पी वी वराले की पीठ ने अपने हालिया

आदेश में कहा कि प्रदीप कुमार उर्फ बानू के खिलाफ फरवरी 2024 में हत्या के प्रयास सहित विभिन्न अपराधों के लिए मामला दर्ज किया गया था, लेकिन अभियोजन पक्ष ने अभी तक मामले से संबंधित 23 गवाहों में से किसी से भी कोई सवाल-जवाब नहीं किए हैं।

पीठ ने पंजाब और हरियाणा उच्च न्यायालय के 11 जुलाई, 2025 के उस आदेश को रद्द कर दिया, जिसमें कुमार की जमानत याचिका खारिज कर दी गई थी।

इसने 13 मार्च के अपने आदेश में कहा, "अभियोजन पक्ष ने अपीलकर्ता के खिलाफ आरोपों को साबित करने के लिए मामले से संबंधित 23 गवाहों में से किसी से भी सवाल-जवाब नहीं किए हैं। इसलिए, मुकदमे को पूरा होने में कुछ समय लग सकता है।"

न्यायालय ने कहा कि कुमार की गिरफ्तारी को लगभग दो साल बीत चुके हैं, लेकिन न तो मुकदमा शुरू हुआ है और न ही इसके नतीजे आने की कोई उम्मीद है।

इंडिया में प्रोडक्ट डिजाइन नहीं करने वाली इलेक्ट्रॉनिक्स कंपनियों को नहीं मिलेगा सरकारी फायदा : अश्विनी वैष्णव

नई दिल्ली@आईएनएस। इलेक्ट्रॉनिक्स और सूचना प्रौद्योगिकी मंत्री अश्विनी वैष्णव ने सोमवार को साफ कर दिया कि इलेक्ट्रॉनिक्स कंपोनेंट मैन्युफैक्चरिंग स्कीम (ईसीएमएस) में शामिल कंपनियों को सरकारी सहायता तभी मिलेगी, जब वे भारत में प्रोडक्ट डिजाइन पर गंभीरता से निवेश करेंगी। राष्ट्रीय राजधानी में एक प्रेस कॉन्फ्रेंस में केंद्रीय मंत्री ने कहा कि प्रोत्साहन और समर्थन अब इस बात से जुड़े होंगे कि कंपनियां देश में डिजाइन, क्वालिटी और इंजीनियरिंग क्षमताओं को कितना विकसित कर रही हैं।

मंत्री ने चेतावनी दी कि अगर कंपनियां सरकार की चार प्रमुख मांगों पर काम नहीं करती हैं, तो वह अगली इंडस्ट्री मीटिंग में शामिल भी नहीं होंगी। वैष्णव ने कहा कि कंपनियों द्वारा डिजाइन और क्वालिटी क्षमताओं को विकसित करने की गति से वे निराश हैं, और अगर सुधार नहीं हुआ तो सरकार कड़े फैसले लेने को तैयार है। उन्होंने चेतावनी देते हुए कहा, अगर इंडस्ट्री हमारी अपेक्षाओं के मुताबिक कदम नहीं उठाती है, तो हम आगे की मंजूरी और फंडिंग रोक सकते हैं। सरकार की अपेक्षाओं को बताते हुए मंत्री ने कहा कि कंपनियों को केवल असेंबली या बेसिक मैन्युफैक्चरिंग तक सीमित नहीं रहना चाहिए, बल्कि उन्हें कॉन्सेप्चुअल डिजाइन, इंजीनियरिंग डिजाइन और मैन्युफैक्चरिंग डिजाइन तक अपनी क्षमता बढ़ानी होगी। मंत्री ने यह भी कहा कि जिन प्रोजेक्ट्स को पहले ही मंजूरी मिल चुकी है, उनमें भी अगर शर्तें पूरी नहीं हुईं, तो फंड जारी नहीं किया जाएगा।
